VOCAL SOLO

Classical (with Ragas- 10 minutes)	Light (5 minutes)

INSTRUMENTAL

Rhythm	Stream & bleaming
Classical 10 minutes/ Light 05 minutes Film songs if any variety will not be allowed	

- D. One act play:-** Duration:- maximum 30 minutes + preparation 15 minimum= 45 minutes
- E. Mono action :-** Ten (ten) minutes.
- F. Fancy dress:-** Time to be declared on the spot by the Organizing Institute.
- G. Debate in Odia/English:-** Maximum of 4+1 minutes Topic to be declared one hour before start of each competition.
- H. Extempore speech:-** 4 (four) minutes on any topic to be selected on draw of lot by the candidates. The candidate shall participate in Odia or English language only.
- I. Creative writing English/Odia:-** 15 minutes (topic to be declared one hour before the competition)
- J. quiz:-** On Cultural and Social Heritage of India, Odisha and General Awareness (individual and group championship will be held)
- k.** General knowledge (written) (Boys/girls)
- l.** Painting (Boys/Girls)
- M.** Jhoti (Girls only)



Rules and guidelines of Annual Cultural & Literary Meet For 2015-16

01	An Institution can present maximum of participant not exceeding 15 (fifteen) students
02	All participant must be regular students of affiliated/ permitted/ Vocational Institutions of the Council and must be identified by the head of the Institution concerned.
03	All participants are bring their identity card for verification in the venue as and where required.
04	One candidate can not participate more then three items.
05	Participants for dance discipline are to bring their customs, dress materials, Instruments only. Tabla & harmonium will be provided by the hosting Institution free of charge for dance and music if required. For painting competitions the participants are to bring their materials. (pre-recorded cassettes are also allowed to be used by dance in solo & group dance.
06	For Instrumental music, participants are allowed to bring their own instruments.
07	At least a team leader/ Manager with participants shall be sent by the sponsoring Institutions to the venue with letter if authorization.
08	TA/DA/DA etc. of the participants & officials shall be borne by the sponsoring Institutions.
09	Accommodation including supply of water & electricity/ durry/ bucket/ beds to the participants & the Officials will be provided by the hosting Institution free of cost.
10	Refreshment charges @ Rs. 60/- (Rupees Sixty) only per participant/per day for maximum of two days shall be paid by the Council on the spot after proper identification on production of Xerox copies of the College identity card.
11	The decision of the Organizing Chairman(Heads of the hosting Institution) is binding on each participant.
12	In the event of any complaint by any participant may an any appeal before the Chairman, CHSE Odisha within fifteen days form the completion of the meet through the sponsoring Institution for redressal. The decision of the Chairman CHSE Odisha is final and binding.
