
**N.B.** : i) e-valuation should be treated as a separate process even if it is conducted within the premises of the valuation zone.

**4. Security :**

As valuation is an important integral part of the examination process, proper arrangement of security during the period of valuation shall also be given due importance. Zone Supervisors should be in touch with the IIC of the nearest Police Station and make arrangement of Police personnel near the valuation zone whether located in the campus or in the institutions of Service Provider ( for e-valuation).

As the role of the Zone Supervisor in flawless completion of valuation process is of paramount importance, you are requested to extend your whole-hearted co-operation in this regard.
