- 2. The participants for each team must not exceed 16 (Sixteen)
- 3. Teams will turn up their own playing gears, balls & sticks.

- 4. If a match end with a draw after the normal playing period of 60 (Sixty) minutes (30-5-30) extra time of 15 minutes play shall be adopted. If the match remains undecided then penalty shall be applied. Five penalty push shall be taken by both the teams one each alternatively. 


